### THE RECIPIENT

Mejar (K) Dato' Ling Kiong Hua has been an entrepreneur since his young age, and possesses under his belt over 30 years of working experience in running businesses related to shipping and marine industries. Mejar is a businessman with a vision and has a knack for diversifying and expanding businesses. He is well equipped with good public relations skills and vast working knowledge. Mejar is a man of many capabilities: formulating meticulous plans, forging cooperative links between parties, giving constructive opinions, and managing resources for optimal utilisation. In particular, Mejar can coordinate a project in such an organised, reliable, safe and efficient manner, basing on the company's policies, OSHA, and in compliance with the local legislative rules and regulations.

### THE COMPANY

Sing Kiong Hong Dockyard Sdn Bhd owns a shipyard which has been managed by Mejar (K) Dato' Ling. The shipyard is a member of Sibu Shipyards Association. Its operation has added synergistic effects to the group.

### INNOVATIVE APPROACHES


The company builds various types of vessels, some of which are customised for specific purposes. Applying the latest and advanced technologies, vessels made in this shipyard are fuel-efficient, powerful and structurally strong for multi-purpose usages. Most of the vessels churned out from this shipyard are used in the oil and gas industry.

The shipyard has its own technical team to take charge of the design and construction of new ships as well as providing quality assurance. Workers from this shipyard are Bureau-Veritas certified, meaning they are competent enough to produce end products that will meet the clients' needs.

### GROWTH STRATEGIES

Mejar's vision is to produce quality vessels with top safety features, environment-friendly, powerful, and useful for multi-purposes.

One of his strategies is that all workers must be well versed in safety measures to attain zero incidents. He has taken various measures such as HSE unit to



safeguard the safety, health, and security of the workers; the protection of assets and the environment is of utmost importance.

#### **THE MANAGEMENT**

Mejar advocates teamwork that can incorporate engagement and empowerment, which is crucial for effective management of his company. He has full confidence in the management team to steer the company forward to greater heights. He believes that a strong relationship built on trust and respect is the basis of high productivity; as in a friendly working environment, staff learn new knowledge and develop new skills fairly quickly, both of which would ultimately empower the workforce to contribute positively to the company.

#### **THE PEOPLE AND CULTURE**

By having employees from different backgrounds with diverse cultures and experiences, Mejar believes that the organisation would be imbued with creative new ideas, fresh perspectives, and new directions. He has established a reward system to appreciate and recognise contributions and accomplishments of the employees. Mejar holds the employees in high esteem as they are vital assets in the company, without whom the company would go nowhere.

#### **ECONOMIC IMPACT**

The shipyard contributes to the economy in the form of foreign earnings, as the company sells vessels to a number of international entities. The construction and repairing of vessels benefit many industrial establishments, such as suppliers of metal plates, electrical equipment, paints, furniture and hardware.

#### **SOCIAL RESPONSIBILITIES**

As a part of CSR, the shipyard under Mejar's leadership has been providing on-the-job training for the locals, who have become skilled seamen in a short time. So far, not less than 500 of them have been absorbed into many of his associated companies that operate vessels. Mejar is the advisor of KRT (Rukun Tetangga Seduan), which is active in various community programmes.

#### **RESILIENCE**

Businesses in all sectors are subjected to the up and down cycles due to external economic factors and globalisation. Mejar's business is no exception, but it has come out from the hard times, especially the recent pandemic and grew stronger.

#### **TRANSFORMATION THROUGH TECHNOLOGY**

Over the years, more and more advanced equipment and machineries have been installed at the shipyard. Recently, the company purchased and installed an auto steel plate cutter, to keep up with the latest shipbuilding technology to stay competitive in the market.



## Mr Lesley Luyoh Akah

**Master Entrepreneur**  
Aspajati Sdn Bhd  
Representing Dewan Usahawan  
Bumiputera Sarawak

### THE RECIPIENT

Lesley Luyoh Akah is a Kayan from the town of Belaga. He graduated from UiTM (University Technology Mara) with a Bachelor degree in Business Studies (ADBS) in 1989. Subsequently, he obtained a chartered degree in Insurance - ACII (Association of Chartered Insurance Institute) of United Kingdom, in 1992.

After completing his studies, Lesley worked as an International Loss Adjuster with Thomas Howell Kiewit (now called Crawford Adjuster) in Kuala Lumpur, and later, Hong Leong Assurance Sdn Bhd, Kuala Lumpur as a Marketing Executive.

After working in the insurance industry in Kuala Lumpur for four years, he joined Edward and Sons Sdn Bhd, a Bumiputera Contractor in the oil and gas industry, in 1994. Lesley left Edward and Sons Sdn Bhd in 2000 to set up his own company, Aspajati Sdn Bhd, on 16 May 2002. Aspajati is a licensed PETRONAS vendor with over a decade-long proven track record of performance and reliable service in the local oil and gas industry.

### THE COMPANY

The name of the company, ASPAJATI, comprises two words. 'ASPA' stands for 'aspiring, and 'JATI' - is short for 'Jati diri'. The latter denotes integrity and professionalism in doing business.

Lesley's experience in oil and gas, gained while working with Edward and Sons Group of Companies, came in handy when he realised that Petronas supports Bumiputras in businesses. Without much hesitation, Lesley established Aspajati Sdn Bhd on 16 May 2002.


Lesley's objective of the company was simple and clear: register Aspajati Sdn Bhd with Petronas as a supplier of industrial products to the oil and gas industry in Malaysia. Initially, the company focused on supplying gaskets, which were a frequently sought-after item for plant maintenance as well as shutdown service and repair.

Lesley's most daunting task was registering the company with Petronas. This is because Petronas has a mandatory requirement: an applying company must have a product principal (dealer or manufacturer) with whom it can partner and collaborate before the registration can be approved.

With the assistance of the Japanese Embassy and business associates, Aspajati was introduced to Nichias Corporation of Japan- a gasket manufacturer. Nichias became Aspajati's principal partner in supplying or servicing gaskets and other related sealing products in Malaysia.

With backing from Nichias Corporation, Aspajati was able to address funding matters by adopting the 'back-





to-back financial agreement'. What the arrangement means is this: when a client orders gasket or any related products, Nichias will supply and deliver them to the client. No payment is made to Nichias until Aspajati is paid by the client (typically after 30 days). This mode of business transaction is still in practice today.

### **INNOVATIVE APPROACHES**

In the beginning, Aspajati supplied finished products to the clients. It was discovered later that some products can be fabricated and manufactured in Bintulu. For this purpose, Aspajati developed its own manual gasket cutting machines capable of cutting all soft gaskets. In addition, Aspajati also fashioned their own cutting blades to cut small tiny stainless-steel wires which are embedded in graphite sheet gaskets. This innovative approach raised the overall competitiveness of products and business operations: higher quality, faster delivery, and lower prices.

Aspajati is cognisant that joints in plants and machineries are the weakest points, and gaskets, flanges, bolt and nuts are used with correct tightening to achieve Mechanical Joint Integrity. In light of this understanding, the company added the said products and services to its license for Mechanical Joint Integrity Service. In addition, Aspajati provides other services, including site measurements, investigation and installation of products during maintenance and shutdown, as well as solutions to leak joints.

### **GROWTH STRATEGIES**

Aspajati's vision is to be the preferred business partner in material supplies and specialist services for the total sealing solution to the oil and gas industry. To realise this dream, Aspajati partnered with global specialists to address Mechanical Joint Integrity issues and collaborated with ECITB-UK (Engineering Construction, Industry, Training Board) to conduct training in Bintulu.

Aspajati also invested in the latest computerised gasket cutting machines to ensure long-term business sustainability and monthly job training for its staff members.

### **THE MANAGEMENT**

The Aspajati management team consists mainly of family members and associates. During plant shutdowns, team members discuss strategies and plans: materials must be delivered on time; technical staff members should always be on hand to address issues; team members constantly liaise with customers or clients to iron out differences. The excellent services provided to Shell MDS Shutdown in 2011 is a good example of Aspajati 'shutdown' team's efficiency.

### **THE PEOPLE AND CULTURE**

Aspajati has standard company policies for Quality, HSE, Drug and Alcohol Abuse, as well as Anti-Bribery

and Corruption; all of which are to be followed by staff members. A reward scheme is also in place: the company gives year-end incentives and remuneration to outstanding staff who perform well and adhere strictly to these policies.

### **ECONOMIC IMPACT**

The company believes that its operations contribute positively to the state economy. Its products and services are critically needed during plant maintenance and shutdown; a delay in delivery of both would result in huge losses to the client. For example: if MLNG is shut down for two weeks, and delivery of the urgently required gaskets is delayed, the client may lose millions of ringgit a day.

### **SOCIAL RESPONSIBILITIES**

As part of the company's corporate responsibility, Aspajati frequently contributes to the community and society. Aspajati has contributed to Bintulu Kite Festival almost every year.

Aspajati took part in the Petronas Outreach Programme at SK Sungai Genaan, Sebauh in 2018. In the recent fire incident in Rh Sambop Belaga, the company contributed money to the victims.

### **RESILIENCE**

The financial difficulties resulting from the Covid-19 pandemic was the greatest challenge the company ever faced. Aspajati was able to sustain itself in part due to its 'preferred supplier' status. During the period, Petronas continued to order gaskets, stud bolt and nut materials via a contract supply agreement, which was awarded in early 2019.

The delivery of products and services encountered many obstacles. Nonetheless, good communication with, and cooperation from the clients saved the day; the company pulled through those trying times. The company was in constant consultation with the Ministry of Trade in Kuala Lumpur to seek advice and obtain work permits during that time, which gave the company an opportunity to forge closer relationships with numerous stakeholders.

### **TRANSFORMATION THROUGH TECHNOLOGY**

As a part of Aspajati's business transformation programme, the company has invested in an SQL system software package, to raise the efficiency of administrative and accounting processes. The company has also acquired the latest laser cutting and computerised CNC machine for cutting gaskets, which was previously done manually.



## MR DENNIS CHIN CHING CHUNG

### Master Entrepreneur

Bormal Engineering Sdn Bhd  
Representing Kuching Chinese General Chamber of  
Commerce & Industry

### THE RECIPIENT

Mr. Dennis Chin Ching Chung is the founding director of several companies, notably Perunding Teknikal, and Bormal Engineering Sdn Bhd. Both are successful and dynamic businesses built from scratch, and major contributors to the state's building and infrastructure industry for over four decades.

Upon graduating with honours in Electrical Engineering from the University of Canterbury in 1973, Chin embarked on his engineering career at Central Canterbury Electricity Board, Sarawak Electricity Supply Corporation (SESCO), and then Shell Malaysia. In total, he garnered 8 years of experience before realising his ambitions to set up his own consultancy firm.

Perunding Teknikal is one of the oldest pioneering Mechanical and Electrical engineering consultancies in Kuching. It is responsible for providing mechanical and electrical solutions for numerous landmark projects throughout Sarawak, including Wisma Sanyan, Menara Sarawak Energy, University of Technology Sarawak, Sarawak State Library, Pullman Hotel and the Spring Shopping Mall.


In 1985, Mr. Dennis Chin founded Bormal Engineering Sdn Bhd, an Engineering, Procurement, Construction and Commissioning (EPCC) contracting company, which capitalises on the increasing need for power engineering infrastructure in the state.

### THE COMPANY

Bormal Engineering Sdn. Bhd. was established in 1985 to carry out electrical, mechanical and civil engineering works. Since its establishment, the company has been awarded various projects by the private commercial sector as well as governmental organisations, such as the Sarawak Electricity Supply Corporation, Sabah Electricity Board, and the Ministry of Rural Development of Malaysia.

The company's active involvement in undertaking electrical contract works throughout the states of Sarawak and Sabah can be broadly categorised into Rural Electrification Schemes, Transmission Lines Erection and Maintenance, Substations, Transformers, Distribution System and Building Construction and Civil Works.

Over the company's 37-year history, the company has undertaken a gamut of projects including civil, mechanical, and electrical engineering works, but primarily specialises in the power industry projects such as Extra High Voltage (EHV) Substation Systems up to 275 kV, Medium Voltage Substations (33 kV), rural electrification scheme (RES) projects, power distribution networks, SARES solar power projects as



well as transmission line projects. A milestone for the company was the construction and commissioning of the Samalaju 275/132/33 kV Substation, which is currently the largest EHV substation in Sarawak.

### **INNOVATIVE APPROACHES**

Throughout the decades, Ir. Dennis Chin has shown his farsightedness as the company evolved. He has identified and successfully steered the company towards niche industries where it can carve out a competitive moat.

### **GROWTH STRATEGIES**

According to Ir. Dennis Chin, the success of a company is greatly dependent on several crucial elements. These attributes comprise: (a) being agile by adapting to changes with continuous improvement; (b) highly committed employees who are clear and kept informed on the direction of the company; (c) sensitive to the market demands and trends; (d) embrace the dynamism of technological advancement to remain competitive; and, (e) ensure that the best decisions are made constantly.

### **THE MANAGEMENT**

As a self-confessed workaholic, Ir. Dennis Chin believes in empowering his staff but at the same time closely monitoring their progress and constantly checking in to pre-empt potential problems. He is known in the company as a serial problem solver and often shares his experiences with the team. Through regular consultations and interactions, knowledge is transferred. Furthermore, such engagements equip the staff with tools necessary for critical problem solving.

### **THE PEOPLE AND CULTURE**

Ir. Dennis Chin strongly believes employees are an organisation's most valuable assets and the key to succeed in today's competitive world. As a leader and mentor in the company, he always develops positive workplace relationships with the employees with the aim of inspiring and driving them to achieve a common goal. He has created a work environment that supports a culture of engagement with one another, that is, information sharing and collaborating.

### **ECONOMIC IMPACT**

Under the guidance of Ir. Dennis Chin, the company has created employment opportunity and training for

many people, especially in the electrical, mechanical and civil engineering sectors. In addition, through the various projects that have been awarded to the company, it has also contributed immensely to the social-economic growth of the State.

### **SOCIAL RESPONSIBILITIES**

Ir. Dennis Chin has always believed in giving back to society and has been an active member of the community. He is currently the President of the Sarawak Kaying Community Association; a post he has held for the past decade. He was also the President of the Federation of Ka Yin Chu Associations of Malaysia from 2017 to 2021. In addition, he is currently serving as Vice-Chairman of Kuching Chung Hua Middle Schools No.1, 3 and 4, and Vice-President of the Kuching Chinese General Chamber of Commerce and Industry. The company was adversely affected by the COVID-19 pandemic. During this period, projects were either halted or delayed. Additionally, the pandemic brought disruption to logistics that led to an increase in material prices. As such, overhead costs rose. Despite this, the company has had zero retrenchments as the management is cognisant the challenging time was only transient. 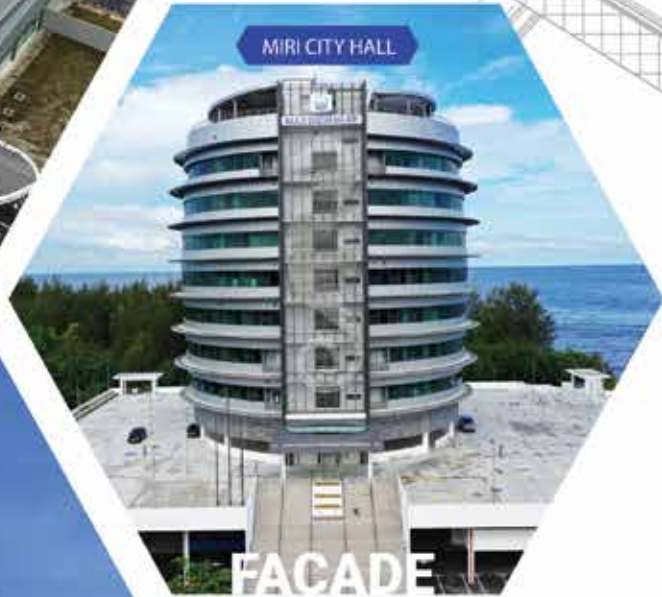

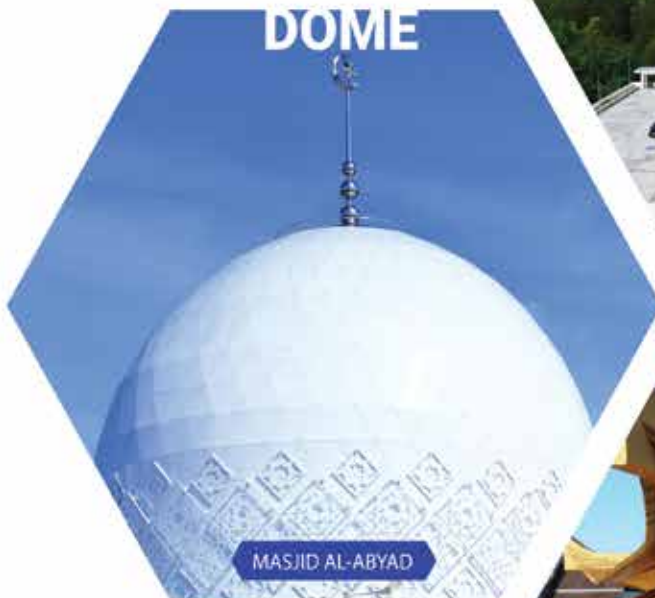
