Rules and Guidelines

PHASE I: STATE LEVEL

- 1. Nominations can be forwarded:
 - a. By each chamber of commerce or other trade and business associations ("business organisations") registered in Sarawak. Such business organisations must be approved by the Awards Organising Committee. Each business organisation shall nominate one nominee only to be honoured for the respective business organisation's Award. A person who has been nominated by his/her business organisation, and was not shortlisted may be re-nominated in subsequent years.
 - b. Independently by an individual nominee which the nomination is to be endorsed by the Awards Organising Committee.
- 2. Nominees are recognised for their entrepreneurship, business innovation or outstanding corporate deals and achievements.
- 3. All nominations shall be submitted by completing the Official Nomination Form. Completion of the Official Nomination Form shall be the sole responsibility of the nominating business organisation or individual nominee.
- 4. The Awards Organising Committee reserves the right to accept or reject all or any of the nominations.
- 5. Information officially provided by nominees and their nominators may be used by the Awards Organising Committee for promotional and publicity purposes.
- 6. The Adjudicating Committee shall be appointed by the Awards Organising Committee.
- 7. Nominations shall be submitted no later than **30 August 2024.**
- 8. The Awards presentation shall be hosted by SCCI. However, SCCI has the discretion to offer the organisation of the Awards presentation to other participating business organisations which are willing to host the event.

PHASE II: NATIONAL LEVEL

- 1. The Awards Organising Committee reserves the right to nominate one or more of the above award recipients for the EY Entrepreneur of the Year Malaysia Award or similar awards at national level. Nominees who do not belong to any of the participating business organisations may be nominated by the Awards Organising Committee to represent the State at the national level awards.
- 2. Notwithstanding the above, any recipient of an Award under this Programme may participate under their own initiative at any national level awards.







The Sarawak Entrepreneur of the Year Awards 2024

The Sarawak Entrepreneur of the Year Awards ("EOYS") is organised by the Ministry of International Trade, Industry and Investment Sarawak, in association with Sarawak Chamber of Commerce & Industry ("SCCI") and EY. EOYS was first launched in 2004 and is a prestigious Awards Programme held annually to honour and acknowledge exceptional entrepreneurial talent and leadership.

The aims and objectives of EOYS:

- 1. To recognise the best in business in Sarawak, i.e. the prime movers that drive the State's path towards economic growth;
- 2. To recognise the success of up and coming entrepreneurs, who through their ingenuity, ideas, resourcefulness, commitment and hard work, have built their businesses which contributed to the growth of our State's economy; and
- 3. To encourage the growth of small and medium scale industries in Sarawak.

The Adjudicating Committee

The Adjudicating Committee will consider a number of criteria in determining the State representative(s) for the EY Entrepreneur of the Year Malaysia Award or similar awards at national level.

In general, the criteria should cover:

- Demonstration of purpose-driven leadership and entrepreneurial spirit vision, dedication as well as intelligent risk taking;
- Company milestones with consideration of industry obstacles and each entrepreneur's ability to overcome adversity;
- · Corporate culture, values and incentives;
- Unique or innovative characteristics of the Company;
- Financial performance, growth record and strategic direction;
- Impact of business on the State's economy;
- Environmental, social and governance initiatives, reputation and contribution to the community that demonstrate the characteristics of a good model corporate citizen;
- Emphasis primarily on the individual's attributes over the Company;
- Resilience in facing the uncertainties of the business environment; and
- Embracing modern technology to enhance efficiency and transformation in the business.
